ASSESSMENT SERVICES - SCHOOLS

Pricing

Pricing for assessment is designed to provide each CPAP assessors with a benchmark remuneration of \$50 - \$60 per hour. There are a number of assessment packages that are available to suit each school budget.

Examinations

There are five packages available.

1. The **'basic'** assessment package: assessors will correct student exams without annotations or comments. This is equivalent to the assessment conducted on behalf of the VCAA. Teachers/students are provided with a score for each question and an overall score for each paper. The price per examination paper is \$11 (inclusive of GST)
2. The **'basic+'** assessment package: the 'basic' assessment package with the addition of an 'Examiner's Report'. The price per examination paper is \$14 (inclusive of GST). [Only available the number of papers being assessed exceeds 15.]
3. The **'basic ++'** assessment package: assessors will correct student exams with annotations and brief comments designed to highlight errors. The price per examination paper is \$22 (inclusive of GST).
4. The **'basic +++'** assessment package: the 'basic +' package with the addition of an 'Examiner's Report'. The price per examination paper is \$27.50 (inclusive of GST). [Only available the number of papers being assessed exceeds 15.]
5. The **'premium'** assessment package: assessors will correct student exams with annotations and comments designed to highlight errors and provide advice for improvement. This package also includes the preparation of an 'Examiner's Report' in the event that the number of papers being assessed exceeds 15. The price per examination paper is \$33 (inclusive of GST).

The pricing for examinations is summarised in Table 1 below:

Assessment tasks/SACs

Given that the size of assessment tasks varies across subjects and tasks, pricing is based on the number of marks allocated to each task. The same five packages are available and pricing is summarised in Table 2 below:
