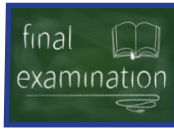

## CPAP Practice Examinations 2025

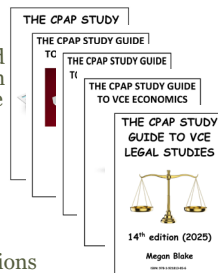
